

Lang Homes is committed to protecting the privacy of individuals. The policy set out below explains the way in which Lang Homes will use, manage and protect your personal information in accordance with Australian privacy laws.

1. Definitions

"We", "us", and "Our" means subsidiaries, related bodies corporate or related entities (within the meaning given in the Corporations Act 2001) of Lang Homes and its respective employees, agents and independent contractors.

"Personal information" has the same meaning as found in section 6 of the Privacy Act 1988.

"Third Party" means any person, corporation or entity not related to Lang Homes.

"You" and "your" means the user of, or visitor to the Website or person or corporation who contacts us via postal, electronic, telephone or other means of communication.

"Website" means this Lang Homes website and any links available from or within the Website, but does not include any external websites or links to external websites not belonging to or controlled by Lang Homes, its subsidiaries, related corporations or entities.

2. Your Privacy

2.1 Unless you state to the contrary, you acknowledge and expressly consent to the use or disclosure of your personal information including your name, address, email address and other information you provide to us as provided for in this privacy policy.

2.2 You acknowledge that any information collected by us has been knowingly provided by you at your sole discretion, and you understand the terms herein on which that information has been collected and disclosed.

3. Collection of Information

3.1 We may collect personal information from you including your name, address, telephone number and email address when you knowingly provide us with information when you visit our website, enter into a competition or promotion, deal with our related entities, participate in a survey, or any 'after sales' follow-ups.

3.2 If we ask for your information and you do not provide it to us, we may not be able to answer any requests you may make to us.

3.3 When browsing our Website we may collect information in connection with your web browser including:

3.3.1 Your IP address;

3.3.2 The type and version of your browser;

3.3.3 The pages that you visit on our Website;

4. Use of your information

- 4.1 Any personal information that you submit to us whether by electronic, postal, telephone or any other method may be used by us for the following purposes:
- 4.1.1 promotion and marketing by us;
 - 4.1.2 for the purpose of gathering statistics;
 - 4.1.3 to monitor the quality and service of our Website; and
 - 4.1.4 to better help us understand your needs in relation to our products and services.
- 4.2 We may choose to contact you by postal, electronic, telephone or any other convenient method.

5. Disclosure of your information

- 5.1 From time to time we may disclose your information as permitted by law to our related entities for the purpose of marketing and promotion.
- 5.2 Unless required or authorised by law we will not disclose your personal information that you submit to us to any Third Party.
- 5.3 We will never publish your personal information on our Website, any public listing or directory or in any of our promotional material without your express consent.

6. Your information

- 6.1 You can access and request correction of any personal information about you if it is inaccurate, incomplete or out of date.
- 6.2 If you no longer want to receive communication from us you may request us to delete your personal information.
- 6.3 Any requests for access to or deletion of your information must be made directly by you contacting us in writing.
- 6.4 We may require you to verify your identity before we grant any of the abovementioned requests.
- 6.5 We will make reasonable endeavours to ensure that the personal information we collect is accurate, complete and up-to-date.
- 6.6 We will make reasonable endeavours to protect your information from misuse, loss, unauthorised access, modification or non-authorised disclosure.

7. Sensitive Information

- 7.1 We will not collect, use or disclose sensitive information (for example racial or ethnic origin, political or trade association membership) except with your express consent or in the circumstances permitted in the Australian Privacy legislation.

7.2 In circumstances where we do collect sensitive information, we may collect this information for marketing purposes or to help us improve our services to better meet the needs of our customers.
